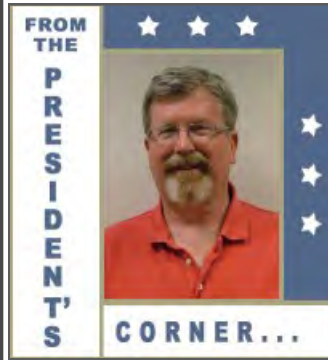

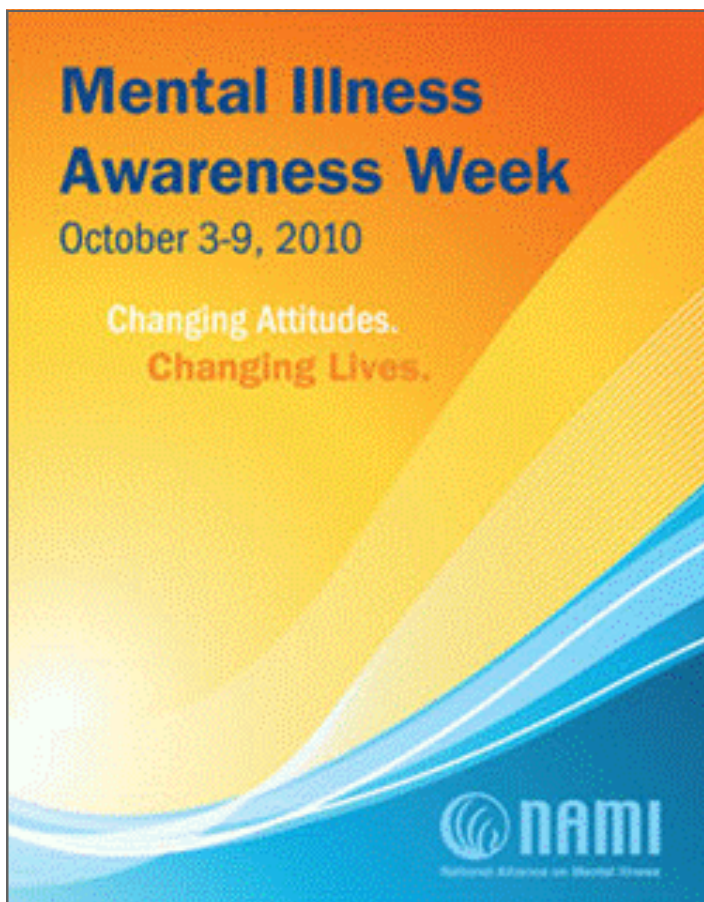



**ALL ABOARD
WITH YOUR BOARD OF DIRECTORS!**

Last month I gave a general overview of how our Board is governed including a discussion on our Bylaws, how Board Members are appointed, how our committee structure works, and when we meet. This month we are going to focus more on specific responsibilities of all boards, including ours!

1. Mission and Purpose - It is the board's responsibility to create and review a statement of mission and purpose that articulates the organization's goals, means, and primary constituents served. This means who we are going to serve, why, and how! Mission statements should be brief and to the point. Our is: NAMI Southwestern Illinois is dedicated to providing support, education and advocacy for persons with mental illnesses, their families and others whose lives are affected by these diseases.

2. Select the Chief Executive – The Board has one employee and that is the Executive Director. Other staff, if any, works for the Executive Director. Boards must reach consensus on the chief executive's responsibilities and undertake a careful search to find the most qualified individual for the position.

3. Support and Evaluate the Chief Executive - The Board should ensure that the chief executive has the moral and professional support he or she needs to further the goals of the organization. This might include introducing the ED to key community leaders. One way our Board works is that I have weekly meetings with the Board President.

4. Planning - Boards must actively participate in an overall planning process and assist in implementing and monitoring the plan's goals. We have a Strategic Plan that was developed through an extensive process with many stakeholders. Have you seen it? Would you like to? Give me a call and we can send you one!

5. Programs – The Board should monitor, and strengthen programs and services. The board's responsibility is to determine which programs are consistent with the organization's mission and monitor their effectiveness. As a NAMI affiliate we strive to deliver the NAMI signature programs such as Family to Family, Basics, In Our

Own Voice, Peer to Peer, and Support Groups but we also have a resource guide and a HelpLine. All our programs are done by trained volunteers. Want to help? Please contact me and I'll get you started.

Remember, as a NAMI member you may attend the second Tuesday of the month Board Business Meeting held at Gateway Regional Medical Center. You are always welcome!

Drug Switching: Tell Us Your Story

NAMI of Southwestern Illinois has been learning about the issue of drug switching, which is the practice of a pharmacy or doctor giving a patient either a generic alternative or a so-called therapeutic equivalent. However, these alternatives and equivalents are usually slightly different than the brand name and therefore can be harmful to the patient. Nationally, NAMI has endorsed proposals that would ban incentive-based drug switching. Since the switch to generics can save money, some doctors are under pressure to prescribe generics instead of the drug the patient needs. With mental health drugs, certain drugs are effective for certain people and alternatives with even a slight difference can produce unintended, negative results. We believe that the patient and the physician in partnership to be the primary determiners of care.

NAMI Southwestern Illinois is looking for stories of drug switching in our region because we are reviewing Illinois state legislation in advance of possible state legislation in 2011. The state legislation would be focused on protecting mental health patients by requiring a doctor to be notified or to approve drug switching.

Consumer Access in Jersey, Calhoun & Greene Counties

On August 12, 2010 the Division of Mental Health received written notification from Tri-County Counseling Center of its intent to cease crisis, casework, counseling and psychiatry operations effective Friday, August 13 at 4:30pm.

The following arrangements have been put into place to ensure that consumers served by Tri-County Counseling Center have continuous access to services and that crisis services remain viable in Jersey, Calhoun and Greene counties:

1. Crisis Services: Effective at 4:30pm today, crisis coverage for Greene County will be assumed by Locust St. Resource Center of Macoupin County. Crisis coverage for Calhoun and Jersey counties will be assumed by Community Counseling Centers of North Madison County. See contact information below.

2. Psychiatry: Consumers formerly receiving psychiatry services at Tri-County Counseling can continue to see their same psychiatrist through September 30th at Community Counseling Centers, Alton Office. Medical record access between Tri-County Counseling and Community Counseling Centers has been negotiated between the two agencies. Consumers who prefer to access services through Locust St. Resource Center are free to do so and cooperative medical record document exchange will occur with proper releases of information.

3. Counseling, Casework, and Community Support Services: Locust St. Resource Center will be establishing a permanent presence in Carrolton (Greene County) and are staffed to provide all services to former Tri-County consumers effective immediately. Community Counseling Centers of North Madison County intends to establish a presence in Jersey County, once it receives authorization by its Board of Directors.

In all instances, primary consideration will be given to consumer preference in terms of where they wish to access services. Mental Health Centers of Central Illinois' Jacksonville office, already serves Green county residents as well, and stands ready to do so per consumer request.

4. Substance Abuse Services: The Division of Alcohol and Substance Abuse (DASA) is conducting an administrative review of services and will be in consultation with area providers. DASA is interested in expediting continuous service as soon as is feasible.

5. Comprehensive Community-Based Youth Services (CCBYS): The CCBYS Information and Referral Line, 888-816-3264, will be available 24/7 to route crisis calls to the appropriate youth service provider for the counties formerly served by Tri-County Counseling Center. Please see attachment for more details.

6. Final closure of Tri-County Counseling: Tri-County Counseling Center has indicated its' intent in writing to maintain a staffing presence to address administrative matters through September 17, 2010. It also plans to operate their residential facility until a smooth transition can be negotiated with a suitable provider.

Walk to Washington D.C. in 50 days to Raise Depression Awareness? by Tod Jurke DBSA Facilitator, Belleville

As music played and the crowd cheered, Steve Curran with his walk team followed the police escort through the park in Troy, Illinois. The Tri Township Park was the location for the first Walk to Washington rally. The event was planned and coordinated with the combined effort of four DBSA (Depression Bipolar Support Alliance) Support Groups. Madison and Saint Clair County DBSA Groups came together as a team to produce the rally which included food, music, balloons, face painting, kid's games and just plain family fun.

The event was held to support the efforts of three people leaving from St. Louis, Aug 14, who will walk all the way to Washington D.C. in 50 days to Raise Depression Awareness. With each mile walked, the walkers will raise awareness for three crucial principles: 1) Ensure equitable and adequate mental health treatment coverage in all public and private health care plans; 2) Support policies that promote individual and family recovery from mental illnesses as integral to overall health; and 3) Commit to investing in America's prevention, early intervention, treatment, and research related to depression.

The Walk to Washington for Depression concludes on Thursday October 7th, 2010 with a rally in Washington, DC

Allsup Commemorates Social Security's 75th Anniversary
Historical data illustrate changes in Social Security retirement, disability programs

Belleville, Ill – Aug. 11, 2010 – When the Social Security Act was signed into law 75 years ago, it introduced a form of economic security that didn't exist for the elderly. Nineteen years later, the disability division was created. The Great Depression was a triggering event for the original legislation, and now, during the current economic crisis, individuals and their families are realizing the crucial support provided by Social Security's programs, according to Allsup, a nationwide provider of Social Security disability representation and Medicare plan selection services.

The Social Security Administration and its nearly 65,000 workers continue to provide an invaluable service to Americans who retire or who can no longer work because of disability, said Jim Allsup, president and CEO of Allsup. We honor SSA workers' dedication to public service and thank them for making these programs possible. We especially recognize their commitment to improve Social Security's disability backlog crisis. We hope that government and industry can work together to ensure that all Americans with disabilities receive the benefits they have earned.

To help commemorate the anniversary that falls on Aug. 14, 2010, Allsup highlights some of the features of the program from then and now, and highlights lesser-known aspects of Social Security. One of those features is the "disability freeze" that protects retirement benefits when someone receives Social Security disability benefits. People receiving Social Security disability benefits eventually transition to retirement benefits when they reach full retirement age. Enacted in 1954, the freeze means that when someone has years of little or no earnings because of a disability, those years are not included in the calculation for retirement benefits. This protects someone's level of retirement benefits and insured status. More insights are provided below.

Social Security: Then and Now

The second way to help save NAMI postage expenses is if you are **going to move or already have moved**, please contact NAMISWI. Did you know that if the Post Office has to return any newsletters to us for incorrect address, no such number, etc, we must pay the returned postage due? This is in addition to the postage that was initially spent on the mailing. That's why it's so important to let us know if you're changing addresses.

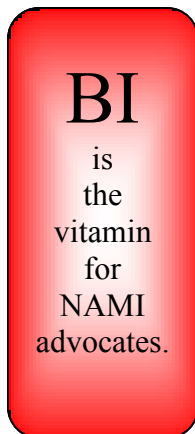
